### **Berks County 2019 Budget Notable Revisions**

#### **Revenue Increase (Decrease):**

- Elections \$421K HAVA Grant for Voting Machines
- Liquid Fuels \$1.3M Highway Planning Funds for Dreibelbis Station Bridge
- Berks Heim (725K) Adjustment for change in census mix

#### **Expenditure Increase (Decrease):**

- Personnel (\$602K) Lowered due to favorable health care trend
- **Special Revenue Fund Match \$900K** General Fund Contribution to the Comm. Ctr.
- Pension Expense \$788K Increased due to lagging investment performance
- Capital \$7.7M
  - Voting Machines \$4.1M
  - Comm. Ctr. \$1.6M GPS Project to be completed in 2019
  - Liquid Fuels \$1.9M adjustments for Dreibelbis Station and other bridges

#### Unassigned General Fund Balance – Decreased by \$4.0M to \$105.0M
