Berks County Commissioners' 2021 Budget Goals

- No property tax increase
- Balanced operating budget without use of reserves
- Limit wage growth to projected CPI
- Limit headcount growth
- No new debt
- Fund new facility infrastructure needs with reserves
- No new, unfunded programs
- Maintain commitment to farmland preservation, education, economic development, library, and park systems
- Maintain long term financial stability and Aaa stable outlook bond rating
- Prioritize capital improvement to:
 - Facility & bridge infrastructure projects
 - Technology/Software

Berks County 2021 Budget Highlights

- Funded Headcount Decrease 23 FTE BH (20.5)/ Added 3 Assistant Directors
- Average wage increase 1.77% ECI index 2.5%
- Health & Dental benefits decrease (2.9%) ECI 1.8%
- Pension Contribution \$5.7M Increase \$0.8M
- Net Debt service \$16.8M No new debt
- Berks Heim Net Loss (\$1.1M) Funded with BH Net Assets
- General Fund support \$13.3M CYS \$6.7M, DRO \$2.3M, MHDD \$0.9M, 911 \$3.5M
- New Programming In-source Children Alliance Center
- Maintains the following commitment to:
 - Economic Development \$750K (Personnel/Marketing/Business outreach)
 - RACC \$3.25M Sponsor operating stipend obligation plus \$600K CDBG Capital
 - BCPS \$249K R3 Pre-Apprentice program plus \$50K CDBG
 - Library System \$3.5M includes \$900K to RPL \$150K increase to member libraries
 - Park System \$3.7M for operations and park improvements
 - COCA \$1.7M for drug and alcohol treatment includes \$300k from CDBG
 - SCTA/BARTA \$420K 5% increase to maximize state funding



Berks County 2021 Budget Potential Risks/Rewards

- Covid 19 duration and financial impacts:
 - Berks Heim Census growth 310 to 365 during 2021
 - Testing BH \$75K/Jail \$200K/Contact Tracing \$70K
 - PPE enough on hand, at current consumption levels, for County needs
 - Sanitation supplies 2021 Budget \$55K Facilities/\$20K Departments
 - Staffing and O.T. costs
 - Tax base bankruptcies
 - State budget cuts & unfunded mandates
 - New Covid Grants
- Outcome of CBA negotiations
- Claim trend and inflation worker comp & health costs
- Pension assets performance and valuation method changes
- Managed Care impact on Berks Heim rates
- Continuation of IGT program Berks Heim
- Timing of new Jail decision and related cost
- Tipping fee revenue outcome of landfill litigation
- Jail ADP budget 950 Impact of pretrial electronic monitoring
